Limited Warranty

This is to certify that all Series 4700, 4710, 5010, 5600, 5610, 6000, 6010, 6050, 6060, 7006, 7010, 8010, 5500PD, 8005PD windows and doors manufactured by MGM Industries, Inc. are fully warranted against defects in material or workmanship under normal use and service for a period of one year from the date of installation.

20 Year Limited Warranty on Main Frames and Sash Frames: Main frames and sash frames are warranted not to pit, corrode, blister, peel or crack under normal use and service for a period of twenty years from the date of installation. For these conditions, MGM Industries will assume 100% of the cost of replacement parts during the first twenty years from the date of installation to the selling dealer.

Locks, keepers, latches, lifts, weather stripping and balances are warranted against defects in material and workmanship for a period of one year from date of installation.

10 Year Limited Warranty on Insulated Glass: Insulated glass is warranted against failure for a period of ten years from the date of purchase. Glass failure is a material obstruction of vision resulting from moisture, dust, or film formation between the interior glass surface of the insulated glass unit. Glass breakage, stress cracks and torn screens are not covered under this warranty. **Any after factory alterations to windows or glass will void the warranty.**

Factory warranty covers materials only, and MGM Industries, Inc. will assume no other expense such as labor costs of any kind for removal or reinstallation.

MGM Industries, Inc. is not liable for any incidental or consequential damages resulting from any defect. Some states do not allow limitations on how long an implied warranty lasts or the exclusion or limitation of incidental or consequential damages; therefore, the above limitation or exclusion may not apply to you.

This warranty is extended to the original purchaser only and is in lieu of all other guarantees or warranties expressed or implied and does not apply to the products normal deterioration, accidents, acts of God, fire abuse, neglect, misuse or installation, other than as recommended by the manufacturer. This warranty gives you specific legal rights and you may also have other rights, which vary from state to state.

Defective windows or parts must be returned to MGM Industries, Inc. freight prepaid.

Warranty Registration Certificate must be completed and mailed to MGM Industries Inc., 287 Freehill Road, Hendersonville, TN 37075, within 90 days of date of window or door installation to validate warranty.

Lifetime Limited Warranty

This is to certify that all replacement windows manufactured by MGM Industries, Inc. are fully warranted against defects in material or workmanship under normal use and service for a period of one year from the date of purchase unless stated otherwise below.

Lifetime Limited Warranty on Main Frames and Sash Frames: Main Frames and sash frames are warranted not to pit, corrode, blister, peel or crack under normal use and service for as long as the original purchaser or property owner resides in the home for which the windows were installed. Any claims for defects under this warranty should be submitted in writing to the contractor who installed the window promptly after discovery detailing the defect claimed. Enclose a copy of this warranty validated by the installing contractor and proof of purchase. Allow a reasonable amount of time for inspection purposes. If, after inspection, it is determined that the claim is valid in accordance with the provisions of this warranty, MGM agrees, at its option, to repair or replace any defective part or component as warranted above when said defective part or component is returned to MGM transportation charges paid. Purchaser/property owner shall pay return transportation charges. Labor costs are not included under this Limited warranty and neither MGM nor its distributors will be responsible for any costs incurred in the removal, replacement, installation, or reinstallation of the window or any part thereof furnished by MGM under this limited warranty.

The original warranty period shall not be extended by any such repair or replacement, but any remaining warranty time period shall continue in effect and be applicable under the terms and conditions of this warranty to the repaired part or component of the window.

MGM reserves the right to discontinue or change any window it manufactures. If the part or component of the window originally installed is not available and MGM determines to make replacement, MGM shall have the right to substitute such part or component designated by MGM to be of equal quality and price.

This warranty is limited to MGM at its option, repairing and replacing defective parts (color matching not guaranteed) free of charge to the original purchaser. The sealed insulated glass unit is warranted against defects resulting in material obstruction of vision from film formation caused by dust or moisture in the dead air space of the sealed unit, for a period of 30 years from date of installation. Should glass fail prior to year 10, MGM will provide you with a replacement sealed glass unit at no charge. Should the glass fail after year 10 as a result of defects described above, then MGM will charge you a fixed percentage of the company's selling price for insulated glass at that time, according to the following formula: Years 10 - 20 -- 50%; Years 20 - 25 -- 75%; Years 25 - 30 -- 90%. This warranty does not cover breakage of glass or torn screen from any cause whatsoever.

This warranty covers only those manufacturing and material defects as specified herein and does not include defects or damages attributable to installation, normal weathering or defects caused by: accident, fire, flood, or other Acts of God, vandalism, riot or civil disorder, misuse, abuse or harmful fumes, vapors or chemical pollutants in the atmosphere, mildew, building settlement or structural failure of walls or foundations, or if subjected to stresses resulting from localized heat which causes excessive temperature differentials over the glass surface and edges, or any other causes or occurrences beyond MGM's control.

Condensation on windows which may occur as the natural result of humidity within the house or building, and interior/exterior temperature differentials, does not indicate a defect in the window and is not included in this warranty. Additional information concerning condensation is available upon request.

Lock, keepers, latches, lifts, weather stripping and balances are warranted against defects in material and workmanship for a period of one year from the date of installation.

On some installations caulking is used to seal the window frames or trim package against water or air penetration. Caulking is not considered part of the window, and therefore is not covered under this warranty. Caulking is normally considered a maintenance responsibility of the homeowner.

This warranty is valid only if windows and doors manufactured by MGM Industries, Inc. are used, but shall be void if window or door accessory products not manufactured by MGM Industries, Inc. are installed which cause defects to occur in the window or door. **Any after factory alterations to windows or glass will void the warranty.**

THE WARRANTY STATEMENTS CONTAINED IN THIS CERTIFICATE SET FORTH THE ONLY EXPRESS WARRANTIES EXTENDED BY MGM INDUSTRIES, INC. FOR WINDOWS AND DOORS AND THE PROVISIONS HEREOF SHALL CONSTITUTE THE PURCHASER'S EXCLUSIVE REMEDY FOR BREACH OF THIS WARRANTY GIVEN UNDER THIS CERTIFICATE. MGM SHALL NOT BE LIABLE TO PROPERTY OWNER FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES FOR BREACH OF ANY WRITTEN OR IMPLIED WARRANTY ON THE WINDOWS OR DOORS.
